

- (a) To Organise, Establish and conduct Educational Charitable Institutions such as Schools, Colleges, Industrial Training Centres, Technical Schools, Libraries, Poor Homes, Orphanages, Hospitals, Dispensaries, Home for the old, destitutes and disabled and for waifs and strays, and such other centres of learning to give Education to students in all field art, Science, and technology and institutions of service and charity.
- (b) To Equip all of or any of these undertakings and to provide residential accommodation, equipment and maintenance, either free of cost or for consideration to teachers, pupils, staff, servants, and others connected with the working of the Trust and to educate, train and assist financial and otherwise, in the education and training of teachers, students, orphans, aged people and other personnels for the working of the Trust.



- (c). To give awards, Scholarships or aids to the brilliant, poor and needy either in cash or in kind.
- (d) To conduct Training Programms in art, science, commerce at Schools, Colleges or other Educational Institutions and such other places.
- (e) To engage in charitable work with a view to improve the living conditions of the poor people and to train young people for charitable and social work.
- (f) To establish, support, and administer social centres, and other charitable and social works.
- (g). To diffuse the latest knowledge and developments in the field of art, science and technology, to impart Religious Knowledge, among students in Educational Institutions
- (h) To hold and arrange audio visual programs, shows, symposiums, seminars, dramas, conferences, and other ventures on Scientific, artistic, technological, and other humanitarian subjects with a view to diffuse the latest knowledge and developments
- (i) To Co-operate with organisations and Institutions which subscribe to the same objectives.
- (j) To print, publish, and exhibit journals, periodicals, books and other reading and pictorial matter for the diffusion of useful information and knowledge and in keeping with the object of the Trust.
- (k) To acquire, possess property both movable and immovable and develop and use the same for the purpose of the Trust.

- (l) To takeover, administer, manage, carry on, conduct, develop, improve and equip all or any of the properties now and hereafter vested in the Trust or any other person, persons, or body and meant or devoted for or to any other purposes of the Trust whether religious, charitable, educational or otherwise.
- (m) To construct such building or buildings and structures as may be necessary and from time to time improve, alter, or extend the same or any part or parts thereof.
- (n) To receive grants, subsidies and donations from any organisation, either Government, Quasi Governments, local or charitable organisations or persons to promote the objects of the Trust.
- (o) To establish and maintain a reserve fund for the purpose of promoting the activities of the Trust and its training programmes.
- (p) To open bank account or accounts in the name of the Trust and to operate them for the purpose of the Trust.
- (q) To invest monies of the Trust in such manner as may be decided from time to time.
- (r) To enter into agreement and execute and register deeds and documents and to do all acts and things for carrying out of the objectives of the Trust and to all other acts and things incidental to or necessary to promote such objectives.
- (s) To make as well as to change "Rules and regulations" for the functioning of the Trust.
- (t) Furthermore, the Trust shall do any and all lawful acts suitable, useful, desirable or proper in order to achieve the above mentioned goals.




The objects of the trust shall be carried out without regard to caste, colour or creed.

4. The trust fund shall consist of the above sum of Rs.1000/- (Rupees one thousand only) and other assets, whether in cash or in kind, that may be received or acquired by the trust from time to time plus accumulations by way of income or otherwise as deducted by the amounts utilised for carrying out the objects of the trust and expenditure incurred in connection therewith.
5. The Trustees shall hold offices as trustees in their official capacities as Archbishop, Protosyncellus, Syncellus and Procurator and they continue to be as trustees only till they hold their respective offices in the Archdiocese of Changanacherry and they have no right to continue as Trustees in their individual capacity.
6. The trustees together shall be known as Board of Trustees and shall have to conduct the affairs of the trust. The Board of Trustees shall have the following powers and duties.
 - (a) To appoint one among them as the Managing Trustee except the first Managing Trustee to fill any vacancy that may exist or occur in the office of the Managing Trustee or in the Board of Trustees and to nominate able and devoted persons to succeed them.
 - (b) To administer and control the affairs of the Trust, the Trust properties, the institutions and establishments belonging to the Trust, or under their management.
 - (c) To make such rules and regulations as are necessary, but not inconsistent with the provisions of this deed for the proper and efficient administration of the Trust and the Institution/establishment belonging to or managed by the Trust.

- (d) To collect funds towards corpus or otherwise, from individuals, Institutions, governments or from any other sources, by way of donations, grants, subsidies, subscriptions or in any other manner, either in cash or in kind.
 - (e) To take loans or advances from individuals, Institutions, banks or other financial Institutions or government pledging the assets of the trust or otherwise.
 - (f) To invest the funds of the Trust consistent with the object of the trust, in any manner as they deem fit such as by acquiring immovable properties, like land or building or by developing the same or by constructing new buildings or acquiring movable properties like government securities bank deposits, company shares or company deposit or other securities etc.,
 - (g) To dispose of or let out any movable or immovable properties or to vary any investment once made, as and when found necessary in the best interest of the trust.
 - (h) To take over or manage any institutions or any activity now carried on by others, or to start fresh activities as long as such action will some way other help to achieve any or all object of the Trust
7. Managing Trustee shall have the following powers and duties.
- (a) To work, manage, control and supervise the affairs of the trust.
 - (b) To gather funds towards the corpus or otherwise for the trust by way of donations or otherwise, from any persons or institution either in cash or in kind for the purpose of the trust

- (c) To take loans or borrow money, as decided by the board of trustees and to execute promissory notes, bonds or the like form or discharge the same by repayments.
- (d) To invest the funds in movable or immovable properties as decided by the board of trustees or to dispose the same in any manner as decided by the board of trustees.
- (e) To spend the income earned or the income of the future for any or all of the objects of the Trust, either directly or by contributing to other genuine Institutions to be spent for the purpose of the trust.
- (f) To enter into any contract, agreement or the like, and to execute and sign in the name and on behalf of the Trust any document as become necessary.
- (g) To recover and receive rent, arrears, interest, dividend, fees, damage or money due in any manner to the Trust from any person and on payment of any money whatsoever due and payable to give proper receipts and discharge for the same and on non-payment of any such dues to file or take any legal proceedings for the recovery and compelling payment there of and for incidental matters.
- (h) To appear and act for and on behalf of the trust in all proceeding in Courts or Tribunals, etc or in any other office or before any other competent authority.
- (i) To sign, verify and file plaints, written statements, petitions, for execution of decrees, and orders of court, to bid for and purchase property in Court sale or otherwise and to sign, file and present appeals or applications in any Court or office and with prior approval of the board of trustees, to compromise, compound or withdraw any case or refer any matter or case to Arbitration/Arbitrators.



- (j) To appoint and constitute Advocates or other attorneys, whenever necessary and to remove them whenever he feels such removal is necessary.
 - (k) To appoint necessary staff and determine their remuneration and condition of Service and retirement benefits for them if necessary to take disciplinary action or suspend or dismiss them as circumstances warrant
 - (l) To delegate any of his duties and functions as Managing Trustee to any other member of the Board of Trustees.
 - (m) To do any and all acts and deeds and things necessary for the efficient management and administration of the trust.
8. The Trustees may meet from time to time to review its activities and for taking important decisions regarding the activities and affairs of the Trust. At least three such meetings shall be held in an year. Such meetings shall be convened by the Managing Trustee. The decisions of the trustees shall be recorded in a book under signature of all the trustees.
9. The trustees shall make arrangements for keeping of proper books of accounts of the trust regarding the fund, its receipts and payments. Such books shall be closed as on 31st March every year or as on such other date as the trustees may decide and an Income and Expenditure account and Balance Sheet shall be drawn up as soon thereafter as possible.
10. The accounts of the trust shall be audited by a Chartered Accountant appointed by the Board of Trustees.




11. The Board of Trustees shall hold a General Meeting which shall ordinarily be held on or before 30th September every year to approve the audited accounts of the Trust.
12. Bank Accounts shall be opened in the name of the Trust and shall be operated by the Managing Trustee with another trustee as decided by the board of trustees. The cash balance which are not immediately required by the trust shall be kept deposited in the bank.
13. If any disputes arises among the trustees about the interpretation of this deed or about the rights and liabilities of the trustees there under to with regard to any other matter that may arise regarding the affairs of the trust it shall be referred to arbitration by arbitrators to be appointed by the trustees for each of them and the decision taken by the arbitrators or umpire, if any appointed by the arbitrators shall be final and binding on all the trustees.
14. Any provisions in this deed except the object clause may be amended, annulled or substituted by the board of trustees agreeing by all of them and with the prior permission of the Commissioner of Income Tax concerned.
15. In the event of the Trust becoming impossible to functioning in accordance with the provisions of this trust deed, the assets of the trust, after discharging all the liabilities and debts, shall be handed over to such other institutions with similar or allied objects of the Archdiocese of Changanacherry.




